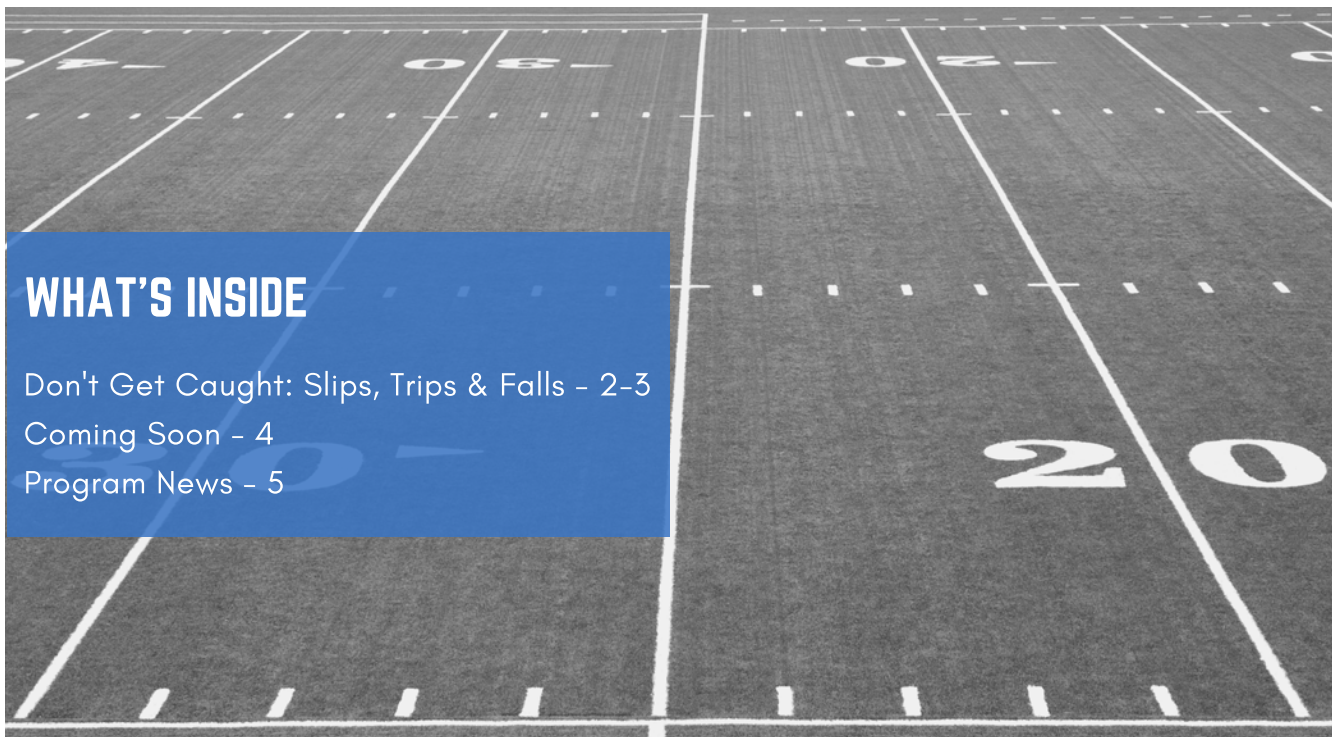

GET READY FOR THE BLITZ!

The ATA Comp Fund and Alliance Interstate Risk Service are excited to announce their inaugural Safety Blitz campaign, to be held **September 13-17, 2021**. The purpose of this Blitz is to create situational awareness for one of the most challenging safety issues and leading causes of workers' comp claims: ***Slips, Trips and Falls***.

The idea for a Safety Blitz came from our inaugural **Risk Management Advisory Committee (RMAC)** meeting in April, where a group of industry leaders came together to discuss current topics, injury trends, safety initiatives and resolutions to solve pressing issues within the transportation industry.

DON'T GET CAUGHT SLIPPIN'... OR TRIPPIN'... OR FALLIN'...

Slips, trips, and falls remain one of the most challenging safety issues for employers and one of the largest causes of workers' compensation claims, including nearly 800 fatalities per year according to the [Bureau of Labor Statistics](#).

Let's take it back to high school for a minute and study some simple physics. **FORCE** is defined as a push or pull acting on an object. Examples of force include **gravity** (pulls everything toward the center of the earth) and **friction** (resistance between objects). Throw in some **momentum** (mass x velocity) and you've got a nice equation to solve... or the setup for a workers' compensation claim.

SLIPS

Slips occur when there is not enough **friction** between your feet and the surface they are on. They are more likely to occur when you do not have proper footwear, are in a hurry, or are not paying attention. *Johnny got distracted by Jenny's new hairstyle in the lunchroom and slipped on a discarded slice of rectangular pizza.*

TRIPS

Trips happen when your foot hits an object and you have enough **momentum** to fall off balance. These are most likely to occur when you are walking or are unaware of your surroundings. *Mary walked nervously to the front of the class to solve for X and tripped over Marty's bookbag.*

FALLS

Falls are the result of losing your balance and **gravity** takes over. They are more likely to occur from heights, but not always. *Biff scrambled down the bleachers to storm the field after the game-winning touchdown, only to miss a step and tumble to the bottom... in front of the entire band.*

According to [The National Institute for Occupational Safety and Health \(NIOSH\)](#), **27% of the 900k nonfatal work injuries in 2018 were due to slips, trips, and falls.**



DON'T GET CAUGHT SLIPPIN'... OR TRIPPIN'... OR FALLIN'...*continued*

Now that you're feeling a sense of nostalgia, let's look at how we can work to prevent these common workplace injuries. It all starts with ***Situational Awareness***, or knowing what is going on around us.



SLIPS

- Use correct 3-points of contact to avoid slipping when climbing up or down from any height.
- Wear sturdy, non-slip footwear and make sure the soles are clean.
- Slow down, especially in hazardous conditions.
- Practice safe walking skills, such as smaller steps and focusing on the walk area.
- Keep walkways free of spills and mark wet/slippery areas with visible signage.

FALLS

- Use correct 3-points of contact to avoid falls when climbing up or down from any height.
- Utilize fixed objects, such as grab bars, for assistance in climbing.
- Use fall protection equipment when working at any height.
- Ladders should be fitted with slip-resistant bases and secured to prevent movement.

TRIPS

- Use 3-points of contact to avoid tripping or missing a step when climbing up or down from any height.
- Walk (and work) in well-lit areas, especially at night.
- Keep walkways free of obstacles and interferences.
- Avoid walking or working on uneven rough ground surfaces.
- Make sure you can see where you are walking; don't carry loads that hinder your line of sight.



Injuries classified as slips, trips, or falls are the second-leading claim reported with the ATA Comp Fund and Alliance Interstate Risk. Since 2000, over 6,000 claims have been paid out, totaling \$105 million, or an average of \$17,500 per claim.
