### **OSHA 101: WHAT EVERY BUSINESS SHOULD KNOW**

Ensuring workplace safety isn't just about compliance — it's about protecting lives, reducing claims, and fostering a culture of care. The Occupational Safety and Health Administration (OSHA) plays a central role in this mission, and understanding its framework is essential for every employer.

#### **III 2024 INJURY & ILLNESS SNAPSHOT**

According to OSHA's latest data:

- 527,116 workplace injury and illness cases were reported.
- 500,572 involved days away from work.
- 410,604 led to job transfers or restrictions.
- 750 workplace fatalities occurred.

These numbers underscore the importance of proactive safety measures — not only to protect workers but also to reduce the financial and legal risks associated with workplace incidents.

#### **✓ EMPLOYER RESPONSIBILITIES**

Employers must:

- Comply with OSHA standards
- Identify and correct hazards
- Provide PPE at no cost
- Maintain injury/illness records
- Report serious incidents promptly
- Avoid retaliation against workers

#### **!** REAL-WORLD CASE STUDIES

#### **K HEAVY TRUCK SHOP SAFETY FAILURE (2024)**

A technician was seriously injured when a hydraulic lift failed during maintenance on a Class 8 truck. The lift had not been inspected in over a year, and safety stands were not used. The truck collapsed, pinning the worker's leg and causing multiple fractures. OSHA cited the shop for multiple violations:

- Hydraulic Lift Safety: No inspection logs or secondary safety supports.
- Lockout/Tagout (LOTO): No energy control procedures or employee training.
- Hazard Communication: Missing Safety Data Sheets (SDS) and chemical training.
- Personal Protective Equipment (PPE): Inadequate gloves and eye protection.
- Housekeeping: Oil spills and cluttered workspaces created trip hazards.

Penalties: \$38,000

Lesson: Skipping basic safety checks—like equipment inspections and LOTO training—can lead to serious injuries and costly fines.

#### **FORKLIFT FATALITY AT A DISTRIBUTION CENTER (2023)**

An Illinois logistics company was cited after a warehouse worker was fatally crushed by a forklift. OSHA found:

- No seatbelt enforcement
- Inadequate pedestrian safety zones
- Lack of operator training

Penalties: Over \$250,000 in fines

Lesson: Forklift safety protocols and training are critical in warehousing and distribution environments.

#### **✓ HEAT ILLNESS IN DELIVERY OPERATIONS (2024)**

A Texas-based delivery company faced OSHA citations after a driver collapsed from heat exhaustion. The investigation revealed:

- No hydration breaks
- Lack of heat illness training
- No weather monitoring protocols

Outcome: Required implementation of a heat illness prevention program

Lesson: Environmental hazards like heat stress are increasingly scrutinized, especially in transportation roles.

#### **TAKE ACTION**

### **SAFETY SPOTLIGHT**

The "Safety Spotlight" feature of The Green Light II shines the spotlight on safety professionals to gain insight into their background, and their thoughts and ideas on safety in our industry.

Meet Christopher Haney, CDS - Director of H.S.S.E. & HR at Payne Trucking. With almost four decades of leadership experience and a career that spans luxury hospitality management and heavy-haul trucking, Christopher Haney knows that Safety is both a science and an art. As a Director of Safety, HR & Risk Management, he oversees everything from compliance to risk management and training representation — all while keeping a sense of humor and a genuine connection with the people he protects. Whether he's representing the company in litigation or swapping stories with drivers in the yard, Chris believes Safety isn't just a policy — it's a promise.



## How did you get started in Safety? What do you view as the main duties of a Safety Director?

My career in Safety was the natural intersection of two worlds — hospitality and trucking. After years in high-profile hotel management, where guest safety and service excellence were non-negotiable, I transitioned into transportation. The stakes were higher, the vehicles bigger, and the regulations... well, let's just say the FMCSA doesn't hand out "frequent flyer points." As a Safety Director, my primary role is to protect lives, property, and the company's reputation. That means ensuring compliance with DOT, OSHA, PHMSA, and environmental regulations, while also building a safety culture where policies aren't just rules on paper but part of everyday operations.

#### What has been the most challenging task in your role/career as a Safety Director?

Changing mindsets. Equipment can be replaced and processes updated, but convincing someone who's been "doing it this way for 30 years" to see a new perspective? That's the real heavy haul. The trick is to pair data with stories, and occasionally, a little humor, to make the medicine go down easier.

# How do you promote your company's safety culture? How do you get employees to "buy in" or get involved?

I focus on communication, recognition, and consistency. I make sure Safety isn't just talked about when something goes wrong. We celebrate milestones, recognize drivers and staff who model safe behavior, and keep Safety top-of-mind without turning it into "background noise." The buy-in happens when people see it's not about discipline — it's about protecting our team and their ability to keep earning a living.

# What advice do you wish you had received early in your safety career? What advice would you give to someone who is starting out in their safety role?

Advice I wish I had received: You can't change everything at once, no matter how many certifications you earn or how much coffee you drink. Advice I give: Listen first, act second. Safety is as much about relationships as regulations. If people trust your intentions, they'll trust your guidance.

#### What is your "One Big Thing" you focus on in your safety role?

Creating a culture where Safety is second nature — not a checklist. When Safety is instinctive, it becomes the foundation for every decision, from the driver's seat to the boardroom.

#### What would be your safety quote or message?


"Safety isn't a rulebook. It's a promise you keep — to yourself, your family, and the person in the vehicle next to you."

#### Any other information you would like to provide?

I've been fortunate to serve in multiple industry leadership roles, from the American Trucking Association's Safety Management Council to the Virginia and Maryland trucking associations. But at the heart of it, I'm still the guy who will roll up his sleeves, walk the yard, and talk shop with drivers. And if we can swap a good story or two along the way — even better.

#### IT'S RENEWAL TIME!

- The deadline for payroll changes is
   October 1<sup>st</sup>. We will be finalizing
   renewals in early October. All payroll
   changes for 2026 renewals must be
   submitted prior to this date. Any
   changes submitted after October 1<sup>st</sup>
   will be reviewed in January.
- Requests for payment plan changes must be submitted by October 1<sup>st</sup>. Current payment plan options are Annual, Quarterly, Monthly Installments, and Monthly Self-Reporting.
- Renewal quotes for 2026 will be emailed to brokers beginning in **mid-October**.
- Requests to non-renew (cancel) must be received in our office no later than 5pm CST on December 1<sup>st</sup>. All notifications received after that time will be subject to 30-day notice of cancellation guidelines, which will be strictly enforced.
